All regular season events will be a \$200.00 entry fee. \$25 from each entry will go to the championship; the remaining \$175 will be a 90% payout. For more details visit www.reelmoneyteamtrail.com

- A team may use one substitute for up to two regular season events.
- Anglers of the Year from each division will fish for free the following year.
- Boat numbers will be assigned in the order entries are received.
- There will be a \$10 late fee for teams that choose to pay the day of the tournament.
- All lakes will be off limits Monday - Thursday the week of the tournament.
- Lunker will be \$10 per regular season tournament and will be a 100% payback.

The boat is guaranteed regardless of entries. The championship will be a 100% payback with a \$300 entry fee. The \$300 entry fee will be disbursed from 2nd place down. The championship location will be a draw and that will be performed at the final regular season event. The three lakes (Blackshear, Eufaula, and Seminole) will go into a nontransparent container. Each lake will be placed onto a poker chip and placed into the nontransparent container. I will then have someone from the crowd that is not a part of the tournament draw a chip. This drawing will take place on July 19, 2014 at Lake Eufaula in Eufaula, Alabama. Teams must fish all 5 tournaments in one division to qualify for this championship. Teams may back pay or choose to not compete in one event. Back pay for a tournament will cost the team \$100. Below are sample paybacks for the championship.
